

## Guide to Understanding and Completing the 2022 Wellness Program Activities

This document will list all available wellness activities for the 2022 wellness program and provide details on how to access and complete each of these items. Employees hired on or before 1/3/2022 may participate in this program and be eligible for the annual reward. Participating employees will need to complete at least one eligible wellness activity in each of the first three quarters in 2022 and remain employed through the end of 2022 in order to receive their reward in January 2023.
