

# How to access your Accident and Health Certificate of Insurance



## What you need to know

Your coverage is effective on the date shown on the “Covered Person Specifications” page located at the beginning of the Certificate. Please note that other eligibility provisions may apply, please see your certificate for more details.

The MyBenefits website, [www.metlife.com/mybenefits](http://www.metlife.com/mybenefits), is a quick and easy way for you to access and print your Certificate of Insurance.

## Access your certificate online

Go to [www.metlife.com/mybenefits](http://www.metlife.com/mybenefits), enter your company name and click ‘submit.’

On the Home Page, click on ‘**Register Now**’ and perform the one-time registration process, if you don’t already have an account.

- Enter your first and last name, identifying data and email address
- Create a unique user name and password for future access to MyBenefits
- For security purposes, choose and answer three identity verification questions to be utilized in the event you forget your password
- Read and agree to the website’s Terms of Use
- A confirmation of your registration will be sent to the email address you provided
- Once you have selected the applicable product, click on the ‘**Certificate Detail**’ tab
- Click on the ‘**View My Most Recent Certificate or Schedule of Insurance**’ link to download and print your certificate
