## It's Easy to Join

Open a Savings Account today.

- Government Issued ID
- Home Address (must match ID or be on acceptable documentation<sup>6</sup>)
- Social Security Number or TIN
- \$5.00 to Open the Account

### Just about anyone can bank with us.

Even if you don't live in Arlington, Fairfax County, City of Alexandria, and/or the City of Falls Church, it's easy to become a member. We have partnered with the Student Conservation Association (SCA), a nonprofit passionate about conservation and workforce development in communities across the country. If you become a member of the SCA, you will be eligible for ACFCU membership, and we'll pay your \$5 SCA membership fee on your behalf!

### The Fine Print

Membership eligibility required. Federally insured by NCUA.

#### CHECKING

1. Cash back is calculated based on the total dollar amount of qualifying debit card transactions. Account will not be interest bearing. 1% cash back on first \$1,000 in transactions. Maximum cash back is \$10. For minimum requirements to be met, actions must be performed and must clear/post to the account during the qualification period. Transactions may take one or more banking days from the date the transaction was made to post and settle against your account. Swipe & Sign, PIN, and Debit Bill Pay transactions must have cleared account by the end of the month. Standard fees will apply such as an account that has been inactive for longer than 12 months. No overdraft fees on transactions up to \$30 for debit card transactions only. ACH transactions do not have a \$30 grace before a fee is charged. Membership required. Federally insured by NCUA.

2. Up to \$10 of ATM fees reversed if reward criteria is met.
3. No overdraft fees for debit card transactions that overdraw by less than \$30. This only applies to debit card transactions. ACH transactions do not have the \$30 grace before a fee is charged.

### CREDIT CARDS

5. Arlington Community FCU is not responsible for merchant codes that do not allow for us to capture the information needed to award double points.

#### ELIGIBILITY

6. Acceptable documentation to verify address include valid U.S. driver's license or state issued identification card; DMV change of address card; utility bill, not more than two months old including electric, gas, water, sewer, cable or phone bill (cellular phone bills are not accepted); annual Social Security statement for the current calendar year; original payroll check stub issued most recently by an employer; certified copy of school records/transcript from the school in which the applicant is currently enrolled, issued by a school accredited by a U.S. state, jurisdiction, or territory (report cards are not accepted); original or certified copy of deed, mortgage, monthly mortgage statement; or an executed residential rental lease agreement; postmarked U.S. mail with forwarding address label (must display the applicant's full name); voter registration card; vehicle registration card; Social Security stub attached to Social Security card.
