What is the overall deductible?	Tier 1a: \$0 person / \$0 person + 1 / \$0 family; Tier 1b: \$250 person / \$500 person + 1 / \$625 family; Tier 2: \$500 person / \$1,000 person + 1 / \$1,250 family.	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes. Emergency care; plus Tier 1b & Tier 2 preventive care are covered before you meet your deductible. Does this plan provide Minimum Essential Coverage? Yes.
